1. Definitions

UnitedCV: the digital service of Dofsky Digital for CVs, cover letters, PDF downloads, credits, and AI help;

- User: every visitor or customer who uses UnitedCV;
- Credits: digital balances that can be used for features such as PDF downloads, Pro templates, or AI actions;
- Digital service: online functionality made available immediately after purchase or use.

2. Applicability

These terms and conditions apply to every use of UnitedCV and to every purchase of credits or digital services through UnitedCV.

3. Service

UnitedCV offers, among other things, a CV builder, cover letter generator, PDF downloads, Pro templates, profile statistics, ranks, and AI help. The service is intended as a tool. UnitedCV does not guarantee that a user will be invited or hired for a job application.

4. No subscription

UnitedCV works with one-time purchases and credits. There is no automatic renewal and no hidden subscription, unless this is expressly offered differently in the future and clearly stated.

5. Credits and packages

Credits are linked to the user after successful payment. Credits are personal, digital, non-transferable, and cannot be exchanged for money. UnitedCV may adjust the credit system for future purchases, but will reasonably respect already purchased credits while the service is active.

6. Payment

Payments are processed via Stripe or another payment provider offered on the website. A purchase is completed when the payment is successfully processed and the credits have been delivered or made available.

7. Right of withdrawal for digital delivery

Because credits and digital features may be made available immediately, the user agrees that delivery starts immediately after purchase. To the extent legally permitted, the right of withdrawal expires once the digital content or credits have been delivered or used. In case of technical issues or an obvious error, the user can contact support.unitedcv@gmail.com. UnitedCV will then reasonably assess an appropriate solution.

8. Use of AI

AI features are intended as writing help. AI may suggest incorrect, incomplete, or less suitable text. The user is responsible for checking, adjusting, and using AI-generated text.

9. Responsibility of the user

The user is responsible for:

- the accuracy of entered data;
- the content of the CV and cover letter;
- keeping their own files and downloads;
- checking PDFs before using them;
- handling their own user ID and browser data carefully.

10. Availability and maintenance

UnitedCV tries to keep the website stable and available, but cannot guarantee that the service always works without errors or interruptions. Maintenance, updates, third-party outages, or technical problems may temporarily affect availability.

11. Liability
